*Breeders Non-Pro classes are all Jackpotted. Payback will be determined by number of paid entries.

** Weanling Open Breeders added money is determined by the number of weanling buy-ins. If there are no weanling buy-ins, the weanling open Breeders classes will be jackpotted and payback will be determined by number of paid entries.

Dispersal Schedule of Stallion Breeders Funds:

Breeders Yearling added money per class = \$1,100 X 4 Classes = \$4,400

Breeders Two Year halter added money per class = \$1,100 x 3 Classes = \$3,300

Breeders Two Year riding added money per class = \$750 x 2 Classes = \$1,500

Breeders Three Year added money per class = \$750 x 2 Classes = \$1,500

- Payment Schedule:**
1. \$100 per horse per class payable by September 27, 2010 (postmark). Any payments accepted after the September 27, 2010 postmark deadline **must be in cash**.
 2. \$100 per horse per class will be accepted at the show until 30 minutes before the first futurity class on Friday evening. Day of show futurity class payments will be cash only. **No exceptions!**

- Buy-Ins:**
1. Any APHA, AQHA or JC stallion from any state may buy in for weanling and yearling breeder's classes. **Buy-Ins the day of show are cash only!!** No refunds on buy-ins.
 2. Only get from participating stallions may participate in the breeder's classes and any get from participating stallions are may show in the breeders classes. (see list of eligible stallions)
 3. Buy-Ins will be accepted for weanling and yearling age groups as follows:
 - \$250 will buy in a stallion's get for weanling age group. Monies will be 100% distributed and evenly divided between both weanling colts and fillies open breeders classes.
 - \$250 will buy in a stallion's get for yearling age group. Monies will be 100% distributed and evenly divided between all four yearling open breeders classes.
 4. There will be no buy-ins for any other age groups.

- Pay Outs:**
1. Award checks will be available the morning following the futurity classes (Saturday). Exact time checks will be distributed will be announced Friday evening.
 2. Non-Pro classes will be jackpotted. Pay outs will be determined by the number of paid entries. No added money for Non-Pro classes.
 3. Pay Outs for Breeder's weanling classes will be determined by the number of buy-ins for that age division.
 4. Pay Outs for Breeder's yearling classes will be increased if there are yearling buy ins for that age division.
 5. In the event there is a tie, awarded placement prize monies will be combined and split evenly between the tied winners. Tie-breaker judge will be announced to determine placement for the awarding of any non-money prize.
 6. If an age group class has no entries, the advertised added money for that class will be distributed evenly throughout the remaining age group breeder's classes.
 7. Award checks will be written to the owner of the horse only as listed on horse's registration papers. Signed transfer papers will not be accepted. No exceptions!! Combined awards of \$600 and more to one owner will require a completed W-9 form from the owner before check(s) is awarded.

All payouts are based on 75% of entry fees + 100% of added monies (if three or more in a class).

- Entries:**
1. APHA breeding stocks are eligible to show in futurity classes.
 2. All horses must have original papers to show in futurity classes, or original facsimile copies from APHA or AQHA. All futurity entries must be accompanied by a copy of the papers, with the original to be presented to the Show Secretary, to receive a back number. **No papers – No show!**

3. \$100 per horse per class payable by September 27th, 2010 (postmark). Checks are to be made out to: Dixie Paint Horse Club.
4. \$100 per horse per class will be accepted at the show until 30 minutes before the first futurity class on Friday evening. **Day of show futurity entry payments will be cash only. No exceptions!**
5. Entries must be accompanied by copies of registration papers. Entries will not be accepted without registration papers as defined above.

Qualifications:

1. Both exhibitor **and** owner of ALL futurity entries must be current 2010 members of Dixie Paint Horse Club. Memberships may be purchased day of show.
2. Non-Pro exhibitors must present a valid and current APHA or AQHA Amateur, Novice Amateur or Youth card.
3. All horses entered in classes in the breeder's futurity classes MUST be in a regular registry of the APHA or AQHA or get of nominated stallions and proof of registration must be shown at the time of entry.

The following stallion's get are eligible for DPHC Stallion breeders – Yearling, Two Year Old and Three Year Old Breeders Futurity Classes. **SPECIAL NOTE:** In the event there is a question as to whether a stallion's name has been left off the list of eligible stallions, it is the responsibility of the stallion owner to present proof in the form of a receipt from DPHCSB.
